Public Remarks: Located almost at the dead end of Old Farm Rd adjacent to 13th Lake, offering privacy and serenity, is this 47+ acres of prime Adirondack forest, comprised of a 7.6 acre lot and a 39+ acre lot, and surrounded on 2 sides by NYS lands! This is the original sight of the 13th Lake Lodge which was built in the mid-late 1800's, and is still an amazing place to build a dream home or compound. There is a small pond on the back corner of the lot, and 13th Lake is within walking distance as is the trailhead for the Siamese Ponds Wilderness Area with miles of trails in a 'forever wild" environment. Garnet Hill Lodge is adjacent to this property and currently the XC Ski trails meander through the property. The zoning is MX 8.5 acre, which allows for subdividing if one chooses.
